NVRRRA Membership Process

- 1) Any current member in good standing of the club can sponsor a new member.
- 2) Prospective members should include their non-refundable fee along with their application; checks should be made out to NVRRRA:

Active Senior Membership--\$60

- 3) The treasurer will record receipt of the application fee.
- 4) The prospective member agrees to serve a trial period:
  - The trial period for applicants to Active Membership will consist of attending at six (6) scheduled meetings that must be completed within four (4) months, or a new application and fee will be required. In addition, the trial period MUST include one (1) monthly business meeting.
  - Exception: if applicant is a prior member who left in good standing, the above trial period is waived for the applicant.

- 5) Membership applications will be stored on top of the black file cabinet in the crew quarters for easy access and to record attendance.
- 6) Upon successful completion of the trial period, the general membership will vote to admit the applicant as stated in the by-laws.
- 7) All senior members in good standing with at least 6 months active service shall have unlimited access to the Association Quarters and facilities. Senior members with LESS than 6 months active service shall have access to the quarters and facilities only during scheduled meetings or in the presence of a senior member who has unlimited rights and privileges.
